A Welcome from Leadership

This past year proved to find new challenges as the pandemic rolled into a second year. The needs of our membership and credential holders shifted from triaging pandemic concerns to finding sustainable solutions for our new normal. ISA focused in the best ways to serve our stakeholders as we managed COVID protocols, travel restrictions and supply chain delays. The ISA Board, under the leadership of President Anne Beard, continued to find new and innovative ways to connect, engage and empower ISA members and credential holders around the globe.

ISA wrapped up 2021 with almost 26,000 members! These members hail from 68 different countries and represent all facets of arboriculture - from tree workers to researchers. This phenomenal milestone shows not only the growth of our industry but the importance of global connections and professional networks. We are so happy to have such a wide and diverse member base.

As an organization, we have conferred almost 50,000 certifications worldwide including our ISA Certified Arborist *, Certified Tree Worker Climber Specialist^{*}, ISA Aerial Lift Specialist^{*}, ISA Municipal Specialist^{*}, ISA Utility Specialist^{*} and ISA Board Certified Master Arborist[®]. And there are 10,000+ Tree Risk Assessment Qualification holders around the world as well.

We are excited to share we've added seven new components this year for a total of 70 organizations around the world that ISA partners with to benefit arborists and urban foresters! We welcomed new components in Peru, Costa Rica, Dakotas ISA, Georgia Arborist Association, Argentina, Chile and Columbia and Malaysia have transitioned from associate organizations to ISA chapters.

From the credentialing side, the new TRAQ Renewal program is now fully online. ISA rolled this new TRAQ renewal option out earlier this year. This new platform allows current qualification holders to have the option to renew their qualifications online. This shift, done in partnership with our ISA component hosts, was done successfully and in record time thanks to our key partnerships and subject matter experts.

Additionally, ISA completed a rebrand and content update for all of our TreesAreGood resources. Our members and credential holders depend on ISA to inform the public about the importance of professional tree care and the importance of having a credentialed arborist work on trees in their communities. The website and consumer brochures have been a huge hit – with our Find An Arborist tool garnering more than 1 million views this past year. This work is one of ISA's top priorities for next year, and get ready to see more focus on consumer outreach and information on the amazing work that arborists do around the world.

And finally, as we begin looking to 2022, we are thrilled to start shifting to in-person events. We are especially excited to host our tree climbing competitions that have been on hiatus for the past two years – and to reconnect with our climbing community. I am also happy to announce we have confirmed locations for our ISA conferences through 2024 -which will be ISA's Centennial celebration! We hope you'll join us in Malmo, Sweden in 2022, Albuquerque, New Mexico US in 2023 and Atlanta, Georgia US in 2024.

Credentialing

The following numbers are the result of a true partnership and commitment of the community that supports ISA and the profession. Despite the challenges presented by the global pandemic, we were able to maintain recertification rates consistent with pre-pandemic levels. The numbers shown here reveal an increase of almost 10% in the total number of applications received (a first-time record of over 6,000 applications received) and a 17% increase in the number of certification examinations administered compared to the last four-year average.

With the assistance of approved instructors and ISA Tree Risk Assessment Qualification (ISA TRAQ) hosts, ISA launched a new training and testing environment for the ISA TRAQ Renewal program, which allowing eligible ISA TRAQ credential holders to complete training and testing requirements from the convenience of their homes.

Finally, ISA also performed two job task analyses (ISA Certified Arborist Utility Specialist[®] and ISA Certified Tree Worker Climber Specialist[®]) which will ensure these examinations are current with the job tasks performed for the practitioners in the field.

Educational Products & Services







At the start of 2021, articles published in Arboriculture & Urban Forestry began receiving Digital Object Identifiers (DOIs). A DOI is a unique ID specific to individual content types, such as journal articles, and allows for persistent linking to the article regardless of where the content itself is hosted. The DOI link allows content to be reliably discovered and shared by the research community at large, increasing citations and visibility for

Articles dating back to 2010 have received DOIs this year, and AUF's registered articles have been accessed a total of 11,310 times (1 January – 31 November, 2021).
